### PERSONAL DATA PROTECTION NOTICE

#### INTRODUCTION

Noble GA Engineering & Services Sdn. Bhd ("Noble GA") respects and committed to protect your personal data and privacy. The Personal Data Protection Notice ("Notice") is issued in accordance with the Personal Data Protection Act 2010 ("PDP Act") in order for "Noble GA" to collect, process and use your personal data. For the purpose of this Notice, Personal Data shall have the meaning as stipulated under the PDP Act. Unless otherwise stated, capitalized terms herein shall have the same meaning as stipulated under the PDP Act.

#### Type of Personal Data

Your personal data may include name, identification number, passport number, address, contact number, email address, mailing address, bank account number, credit or debit card details and/or any other relevant information prescribed under the PDP Act ("Personal Data")

#### Source of Personal Data

"Noble GA" may collect the personal data directly and/or indirectly from the Customer, Dealer and/or Vendor, from any third parties, website, company and/or any public sources to the extent authorized by the law and necessary for "Noble GA" business.

#### Purpose of Collect, Process and Use

During your course of dealing with us, your Personal Data shall be collected and processed by "Noble GA" for the purposes of providing you information about "Noble GA" products and/or services, providing "Noble GA" services, facilitating your purchase of "Noble GA" products, providing your personal information of new products as requested by the new purchaser, to carry out the obligations and/or transactions you have requested, agreed and/or authorized "Noble GA" to do so, to request additional information on the feedback that you may provide about "Noble GA" products and/or services which currently use by you, to obtain response in relation to "Noble GA" products and/or services, to provide you with advance notice about "Noble GA" events in order for you to participate into "Noble GA" events and/or programme, to provide you with "Noble GA" latest products and/or services and/or other purposes referred to in "Noble GA" Personal Data Protection Policy ("Purposes"). "Noble GA" will not use your Personal Data beyond the purpose authorized under any law and regulations.

#### Sensitive Data

"Noble GA" will not acquire, use or disclose to any third party on any sensitive personal data including information as to political affiliation, medical condition, ethic group, religion or any other sensitive personal data as prescribed in PDP Act from time to time unless is authorized by the law.

#### Disclosure of Personal Data

Your Personal Data provided to "Noble GA" shall be kept confidential in general except the following in order for smooth business transaction with "Noble GA": -

#### Data Transferred and Shared Usage

"Noble GA" may transfer and share your Personal Data outside of Malaysia for the purpose of data storage and processing and when it's necessary for such transfer and share of your Personal Data for the Purposes.

### Management of Personal Data

"Noble GA" is committed to maintain and store your Personal Data in a secure and appropriate manner. "Noble GA" is committed to prevent the unauthorized or unlawful processing of your Personal Data, the accidental loss or destruction of, or damage to, or falsification of, or leakage of your Personal Data by implementation of appropriate administrative and security procedures whenever practicable.

### Retention of Personal Data

Your Personal Data shall be retained by "Noble GA" for as long as it is necessary for "Noble GA" to carry out the Purposes with your consent. Your Personal Data will be disposed in an appropriate manner when there is no necessity for "Noble GA" to collect, process and use your Personal Data.

### Rights of Access and Correction

It will be necessary for "Noble GA" to process your Personal Data for the Purposes, without which we will not be able to carry out the Purposes. Such amendments will be announced to you via our website and/or any other appropriate mediums. Such amendments shall only apply to Personal Data collected after the effective date of such revised "Noble GA" Personal Data Protection Policy and Notice.

This Notice is issued in both English and Bahasa Malaysia in accordance with Section 7(3) of the PDP Act. In the event of any inconsistencies, the English version shall prevail.
